AN ORDINANCE TO AMEND CHAPTER 93, FEES, OF THE MUNICIPAL CODE OF THE TOWN OF DEWEY BEACH, DELAWARE, 2005, AS AMENDED, RELATING TO COPY FEES

WHEREAS, the Commissioners of the Town of Dewey Beach find it proper and fiscally responsible to account for copying fees.

NOW THEREFORE, BE IT ENACTED AND ORDAINED, by the Commissioners of the Town of Dewey Beach, Sussex County, Delaware, in session met, as follows:

Section 1. Chapter 93, Article II, Section 93-7, of the Municipal Code of Dewey Beach, Delaware, 2005, as amended, is hereby further amended by renumbering Section 93-7 as 93-8, and further amending new Section 93-8, Subsection H, as follows:

H. Copy charge per page: \$1.

Section 2. Chapter 93, Article I, of the Municipal Code of Dewey Beach, Delaware, 2005, as amended, is hereby further amended by adding new Section 93-7 to Article I as follows:

§ 93-7. Administrative and other miscellaneous fees.

A. Copy fee per page: \$1.


B. Bad check fee: \$50.

C. Fax charge per page: \$0.50.

Section 3. If any provision of this Ordinance shall be deemed or held to be invalid or unenforceable for any reason whatsoever, then such invalidity or unenforceability shall not affect any other provision of this Ordinance which may be given effect without such invalid or unenforceable provision, and to this end, the provisions of this Ordinance are hereby declared to be severable.

Section 4. This Ordinance shall take effect immediately upon its adoption by a majority vote of all Commissioners of the Town of Dewey Beach.

SYNOPSIS: This Ordinance implements a \$1 per page copy fee for copies made by administrative departments of the Town, and raises the per page copy fee from \$0.50 to \$1 for copies made by the Police Department. The Ordinance also implements an administrative bad check fee of \$50, and an administrative fax charge of \$0.50 per page.
