Item #13: Selectmen's Public Comments

Stephan: Karen and I attended the Culture & Arts Committee at the Fish Bypass and the disorder and overgrowth there was discouraging. It gives me concern as to what the Greenway Trail will be like when it is complete.

Kurt: It has been taken care of already.

Karen: I was shocked by the condition as well. I know the original agreement was that the State would maintain the channel and the Town would maintain the park. We have not. Apart from some wildflowers and ornamental grass, there is a ton of poison sumac. There are small trees growing near the wall and they will encroach on the wall and damage it if they are not removed. Also, the new rotary is overgrown. I know it's not a focal point for many people, but it's my understanding that the Town assumed responsibility for the maintenance of it. I'd also like to reiterate what Stephan said about the Greenway Trail.

Kurt – We had the downtown attendant assigned to the Bypass but it was too much for him. That has been moved over to Public Works, who will maintain both. I agree with both of your comments. I'll speak to the Director of Public Works about the Rotary. They have two people assigned to maintain places like that.

Karen – I'd also like to say I'm proud of the Seymour High School cheerleaders.

Len – I'd be interested in the state of Lake Housatonic. I don't think we've heard from them the entire time I've been on this Board. All I've ever seen is their funding request. Algae and bacteria closures of Indian Wells are of particular concern.

Annmarie – I'm really proud of the Seymour High School cheerleaders, many of whom came up through Pop Warner cheerleading. Also for the Fish Bypass, I wish I'd known to bring it up I would have last night at the Public Works Board.

Nicole – Congratulations again to the cheerleaders, they did a great job. I'm also concerned about the Bypass but it's important to reach out to Kurt and let him know our concerns.
