SPECIAL MEETING BOARD OF POLICE COMMISSIONERS THURSDAY, JANUARY 16, 2020 6:30 P.M. 11 FRANKLIN STREET SEYMOUR POLICE DEPARTMENT

- 1. Meeting was called to order** at 6:30 p.m. by Chairman Koskelowski

- 3. Public comment:**

Commissioner Bennett-trying to understand why this is a special meeting? I never received a call that the regular meeting was cancelled and I was not considered if I would be available for tonight's meeting.

Management report: Chief Satkowski**-budget looks good, February 3rd is the budget presentation, department flow sheet and the responsibilities of the Deputy Chiefs handed out, Officer Gallo and K-9 Argus have finished training, FOI training completed, 2 new interns have started, one officer out on long term, one officer out on light duty and the \$ 5,000 FEMA money was approved by the selectmen.

Chairman Koskelowski-when will all employees be evaluated? evaluations have not been done in years but I agree that a committee should be formed to get a new system, will give committee sixty days to get a plan together, evaluations show the performance of the employee, I would like to appoint two members of the Board-Tom and Dave-to represent-committee will be made up of seven members including Inspector, Sgt., Cmdr., Union, administrator, come back at the March meeting with a report.

Chief Satkowski-we are in the process to come up with an evaluation that is fair and impartial, an evaluation system to be fair to everyone.

Deputy Chief Prajer-there have been some errors that come into play with the rating system, working with South Central Criminal Justice to compile data in order to be fair, would like to form a committee to come up with a system that is fair to all parties involved and implement that change as all stake holders have had input, I feel putting a committee together and training is the best.

Commissioner Bitso-some evaluations look busy and who are the committee members? When was the last time an evaluation was done? definitely not used for disciplinary-helps where you might need help, I feel it is a positive and agree to do it right.

Commissioner Bennett-what was the last form used? What is the purpose of the evaluation? Would it be used for disciplinary or more for promotions?

Commissioner Kelley-the evaluation would not be used for disciplinary but for performance.

Commissioner Duke-on the evaluation it should be noted if a very low or high score is given and why.

Chief Satkowski-this is a bare bones budget-besides salary account which is per contract, three cars maybe cut, total budget is \$ 4,571,396.

Approval of High School Scholarships

Kyle Kelley/David Bitso motion to approve, but not to exceed, \$ 2,000 for high school scholarships and the monies to come from the community account. **Motion: 5:0**

Chairman Koskelowski-made a comment-it was not a motion-about all the people in the department doing a good job-this was not an evaluation-just a view point.

Tom Bennett/David Bitso motion to accept Deputy Chief Prajer's retirement letter in good standing. **Motion: 5:0**

Deputy Chief Prajer-it has been my honor to serve the citizens of Seymour, a fantastic career, proud to be a part of this organization and thank you Chief Metzler, Chief Satkowski, Board and my colleagues.

Chairman Koskelowski-Officer Rupsis has been offered a position with Naugatuck as a part time evidence officer-will not go on patrol-were concerned about liability.

David Bitso/John Duke motion to allow Officer Rupsis to remain as a Seymour supernumerary police officer at this time for the next six months and then we would re-evaluate it and that he will be sworn in as a Naugatuck police officer to only do evidence and not any patrol. This is a onetime thing since he is only a part time police officer-only a onetime thing with this request and nothing in the future will hold us to this allowing other officers to do this. Re-evaluate this in six months to make sure Officer Rupsis is pulling his fair share with our department.
