Matt Nitski representing the applicant stated that they are asking for a partial permit to start construction on the house. This will have no effect on the lower wetlands. He submitted a letter from the Army Corps. He stated that no other work can begin until the Army Corps gets back to them. B. Nesteriak stated that the house is outside the regulated area but how you get to the house is not. M. Nitski stated that they will be doing some grading work. There is gravel along the driveway so it is stabilized. M. Flynn stated that this project has been going on for a long time. He felt that a partial permit would get things underway. M. Nitski stated that the stockpiles have been removed and the property cleaned up. They want to make sure the culvert is reinforced. They will be running conduits for electricity.

MOTION: M. Flynn/P.J. Weitzler to grant a partial permit to build the House and driveway leading to it and put in the electrical Conduits.


J. Baldwin stated that the Seymour Conservation Commission has re-formed and they will be doing a land inventory. They are an advisory board.
