4th Quarter 2016 Executive Summary

First Selectman's Office

- \$4.5 million in bonding for road improvements approved by voters
- \$1.5 million in bonding for building improvement approved by voters
- Rimmon Street reconstruction project bid awarded
- Greenway Trail Phase I project bid awarded
- Streetlight audit for LED conversion began
- Began planning for Solarize Seymour campaign
- Raised over \$10,000 for Seymour pink by pushing car during 5k with other community leaders

The fourth quarter of 2016 was quiet in the Town of Seymour. Several large infrastructure projects received approval and are ready for construction in the first quarter of 2017. Most notably, voters overwhelmingly approved \$6 million dollars in bonding, \$4.5 million of which is slated to be used to continue executing Seymour's comprehensive road improvement plan. Additionally, \$1.5 million in bonding for necessary repairs and improvements to municipal buildings, including HVAC upgrades, roof repairs and energy efficiency improvements were also approved.

The long-awaited Rimmon Street reconstruction project is finally ready to begin and will extend through summer 2018. Residents in the area will receive more information soon. Also, the first phase of Seymour's Greenway Trail, extending from the Paul Pawlak Bypass Channel & Park to the Bank Street Bridge, was awarded and construction should begin in the second quarter of 2017. Subsequent phases are already planned to connect to the Broad Street Park.

The LED streetlight conversion project approved last quarter began in December. The contractor will audit our existing streetlights to verify the utility's records in preparation for construction in the spring. Seymour will also be conducting a Solarize campaign in which Town officials interview and vet installers and facilitate outreach to residents in order to encourage the adoption of residential solar.

Finally, it was my pleasure to participate in this year's Seymour Pink 5K. In order to keep upping the ante, a team of leaders from various organizations in Seymour helped me to push a car the entire length of the 5K and in doing so we raised more than \$13,000 for Seymour Pink. Thank you to everyone who participated and especially to those who helped.
