REQUEST FOR BID

Subject: Sale of 1979 Dodge Power Wagon Custom 400 Mini Pumper

The Town of Seymour through the Office of the First Selectman will receive SEALED BIDS for the sale of the equipment described in the accompanying Schedule A, in accordance with the instructions, conditions and reservations that follow:

A. CLOSING DATE:

Pursuant to Section 286 of the Seymour Town Code, proposals will be received until 11:00 a.m. July 30, 2015, in the Office of the First Selectman, Town Hall, 1 First Street, Seymour, Connecticut.

Any proposal may be withdrawn prior to the above-scheduled time for receiving bids or authorized postponement thereof. Any proposals received after the date and time specified shall NOT be considered. No bidder may withdraw a proposal within 45 days after the actual opening thereof. **Minimum bid: \$5,000.00.**

B. INSTRUCTIONS:

Proposals must be delivered to:

a. All bids must be received by first selectman by the specified date. All bids must be sealed. All bids must be legibly printed or typed in letter form or on the town's bid form. All bids must be signed by the bidder. The bids must contain a description of the property bid on, the price bid, the name and address of the bidder. Each bid shall be accompanied by a certified check for at least five percent of the amount of the bid. Each bid shall be dated when received by the first selectman. In the event of identical bids, the first received shall be accepted.

b. The bids shall be opened by the board of selectmen at their first meeting after the close of bids. The first selectman shall then post a notice of the highest bid on the town bulletin board in the town hall. The highest bidder shall also be notified by mail. Any bid, or all bids, may be rejected by the board of selectmen if they consider it in the best interest of the town.

c. The highest bid shall be accepted when payment of the full bid amount is made. The highest bidder is given three working days from the time of posting of the notice of the highest bid on the town hall bulletin board in which to make payment to the first selectman. If the highest bidder

does not pay within the three days, the second highest bid shall be considered the highest bid, and the process shall be repeated. Payment shall be made by cash, certified check or bank check.

d. All property must be removed from town property within three working days after payment is made. If not removed, the property will be removed by the town at the purchaser's expense.

C. RESERVATIONS:

The Town of Seymour may consider informal any proposal not prepared and submitted to the Town in accordance with the provisions herein stated. The Town of Seymour reserves the right to reject any or all proposals or parts of proposals; to waive defects in same proposals; or to accept any proposal or part thereof deemed to be in the best interests of the Town of Seymour.
