Minutes of the Seymour WPCA – Special Meeting at April 7th, 2020- Via teleconference 6pm

Members Present: Jim Cretella, John Uhelsky, Annmarie Drugonis, Nick Teodosio, and Don Sosonovich.

Others present: Walter Royals, Veolia Water Plant manager, Veolia Water, Jon Marro, Atty. Ben Proto, Jim Galligan, P.E. and other members of the public.

Jim Cretella called to order the meeting at 6:00pm.

Approval of the March 2nd, 2020 minutes- John Uhelsky made a motion, Don Sosonovich 2nd, to approve the minutes. Motion passed 5-0.

Veolia Water Reports-

Plant was in compliance for the month of March 2020. Walter Royals submitted the maintenance/operations/collections report to the board, and asked if there were any questions.

Income report – Jon Marro submitted this to the board. Two billing adjustments were talked about; 84 Cedar St -adjustment of \$501.38 needed (house was vacant), 756 Derby Ave – adjustment of \$906.18 needed. Nick Teodosio made a motion, John Uhelsky 2^{nd} , to accept the adjustments. Motion passed 5-0.

Financial Report- this was submitted to the board.

Invoices – the following invoices (see attached) were submitted to the board for authorization for payment. Discussion ensued how the invoices would be signed and then transmitted to the Finance Office. John Uhelsky made a motion, Don Sosonovich 2nd, to accept the invoices for payment and authorized the signing/transmission of the signed invoices. Motion passed 5-0.

Legal Report - Atty. Proto reported on a re-payment on a sewer assessment that is past-due.

Discussion ensued about sewer assessments and repayment.

Atty Proto reported on how the State of CT (Governor's Executive order)- To allow towns to reduce interest from 18 to 3 percent, and also deferment of taxes (including sewer). The town has to approve and notify the state about joining the aforementioned programs, and once enacted the WPCA can do the reduction/deferment for approximately 90-days.

Engineering Report- Jim Galligan reported on the relining/clean/t.v. of Manners Avenue, - cleaned and televised the sewer line and then re-lined the pipe. No issues or interruption of service.

Air exchangers on the roof are in place on the roof, Jim Galligan reported, and are awaiting electrical connection by Bill Jarvis, Jr. – For the short-term the biofilter will have to be given new media, to have it function as a biofilter.

Registration Permit for plant- Jim Galligan reported that 6 items were missing from the permit application, and his staff is working on getting them for the CTDEEP.

New Business- None.

Executive Session- none.

Adjournment- John Uhelsky made a motion, Nick Teodosio 2nd, to adjourn the meeting. Motion passed 5-0. Meeting ended at 6:25pm.

Seymour Water Pollution Control Facility March 2020 Monthly Report

Highlights/Summary

Operational Performance / Compliance:

All NPDES permit parameters and monitoring requirements were in compliance for the month of March 2020.

Plant repair and maintenance items etc:

- Installed new thickener speed controller on east dewatering drums, to replace failed unit.
- Ralph Mann Installed new belts on Odor control Fans and fastened covers.
- Ct. Crane Inspected hoists at Treatment Plant and Pump Stations.
- Shut down, pumped out and cleaned #1 North Secondary clarifier.
- Repaired Pri. sludge manual plunger.
- Replaced compressor motor for Blower #3 purge valve.
- · Summit toyota forklift replaced Starter motor on forklift.
- Began feeding PAC to system to lower phosphorus concentration before April 1st.
- Ralph Mann hooked up new fuel lines from new fuel tanks.
- JJ Brennan Construction installed and tested new Heating Fuel and Emergency Generator fuel tanks and piping.
- N&Y Rep etc. Installed the two new roof exhaust fans. Jarvis electrical is working on electrical hook up and controls for fans.
- Checked #2 Main Sewage pump for rags /blockages. No blockage in pump.Reset pump.

Collection System:

- Weekly Pump Station checks.
- DJ Petrucelli used camera to locate lateral on sewer main for 66 Glen Circle tie in.
- Tested high level alarms at Nicklemine pump Station.
- Inspected Rennay St. Siphon outlet. Normal flow conditions
- Jarvis electrical completed electrical repairs at 8 Nicklemin Drive due to past back-up.
- Inspected Kinneytown, Colony St , and Klarides Siphons . Normal flow conditions
- Marked out manhole at West St and Rt.67. It was called in by Seymour PD (Manhole frame needs to be raised), Manhole cover has recently been paved over
