Household Hazardous Waste Collection Event: May 2-3



In an effort to protect children, pets and the environment, a special hazardous waste collection event will be held **May 2, 10:00 a.m. to 6:00 p.m.** and **May 3, 8:00 a.m. to 2:00 p.m.** at the Centre County Recycling & Refuse Authority, [253 Transfer Road](#). Residents may bring such items as insecticides, weed killers, pool chemicals, cleaners, poisons, corrosives, flammables, oil based paints, CFL bulbs and most other

hazardous chemicals from households only. **Residents are asked NOT TO BRING:** latex paint, used motor oil, antifreeze, medications and alkaline batteries. Residents may contact the Centre County Recycling & Refuse Authority at **238-7005** or ccrra@centrecountyrecycles.org with any questions.
