

Forty-three (43) total absentee ballots; and



In an election at least two registrars from opposing parties must execute this affidavit; in a primary one registrar must execute this affidavit. Any person who is authorized by statute to take oaths may administer the oath. The executed affidavit should be sealed in the depository envelope containing the absentee ballot counters' notes and the counted absentee ballots.




