



Q2 Are open space and recreational facilities a factor in your decision to visit or live in Ocean City?



Q3 How many years have you visited and/or lived in Ocean City?



Q4 How many people in your household fall into the following age categories? (Please enter number in each interval)



Q5 How would you rate the importance of natural open space?



Q6 If you think more open space is needed in Ocean City what are the primary reasons for additional open space?



Q7 What factors do you consider when visiting a recreational facility?


