DVFA – President Richard Perillo, turned the report over to, Bill Betts – Joint Finance Committee meeting is February 12th at 11:30 a.m. and Legislative Priorities this year are to have mutual aid back up to 100 percent, also add \$1,000,000 to the revolving loan fund, we also want \$75,000 for leveling up 50/50 monies in Fire Prevention Awards, and check out the Survey Monkey (<https://www.surveymonkey.com/r/K7QSY8V>) for your opinion on the symposium and location of future conference. As was stated in the paper the State has adopted the plan for First Net from AT&T and we will be offered a good rate on cell phones. Your Pension billing list is due by January 22nd with monies due in by February 15th to the Treasurer. Tax Credit information for the \$400 return needs to be in by January 31st to the Department of Finance.

Pleased to announce we have partnered up with First Net and they are giving us a \$5000.00 grant to run the Cardio Kinetics program. We currently have 12 officers going through.

They don't care who administers they will document it so they can get us some supplies and looking for a fund to develop that. DFIRs has been revived with no problems yet. HB 243 authorized Fire Prevention Commission to insure Volunteer Fire Companies comply with the Audit Requirements on the findings of the Review Task Force. Another about to be introduced would allow EMT's and Volunteer Firefighter's to administer an antidote for Opioid overdose.

New Business:

Vice President Brittingham, a timeline of events with regards to letter from Bowers Fire Company. On December 7th I received a telephone call informing me that Jeff Denison was arrested 7 counts of child endangerment and offensive touching. I received a call from his home company explaining the letter you got, which I asked for in writing and received it on December 8th. On December 7th I had reached out to President Perillo to make him aware of the situation and get his feedback. On December 8th I sent an email to Jeff Dennison using the same verbiage as his home Company and I placed him on Administrative Leave (Suspension) pending the outcome of a court trial. I contacted all the officers after that stating we take no position. We would let the criminal justice system do its duty. Everyone is innocent until proven guilty. Following that I turned to the By-laws, they were very vague. Letter required from the home company for the office. It says nothing after you are already a candidate. I turned to Past Presidents and then I went back to the By-Laws Article 5 Section 8 where it is stated "The Directors shall investigate all matters as assigned affecting the efficiency of the Association, and report their findings and to the Association." At the State meeting, I met with the BOD and turned this over to them. Last night I found out from Jeff Dennison that he goes to trial on February 8th and as of now they are showing all misdemeanor charges. After talking to the BOD tonight, we decided to wait until February 8th and if found not guilty on all charges then go through process of reinstatement. If Jeff Dennison is found guilty then he will turn that information into us and I will turn it over to the BOD and they will report back next month and we will determine as a group/body on what the right course of action to take after that. To make sure we are on the same page come the 8th if he pleads guilty or is convicted of any crime it will be turned over to our BOD and they will review and report back their findings on the trial at the next meeting. Then the Association will determine what to do via motion and vote. Vice President Brittingham then tabled it until the February meeting.
