DVFA – Richard Toulson, a thanks to those of you who participated at CFSI in Washington D.C., probably more important because of all the cuts happening in the budget over at Washington. As you can tell here in our own state we have 5 pieces of legislation. With the news that just came out from the state budget income we are waiting to see what happens. One of the bills that will not be affected is the Home Town Heroes referencing if you are killed in the line of duty you get a benefit amounting to \$150,000 to go along with the Federal. HB 315, 317, SB 207 that is going to run. One is going is tabled dealing with the County Governments Rep. Carson is asking a committee be formed to have dialog between County, Fire Service, and Legislators before proceeding. Bills have made it out of their committees and HB 315 should not have any problems. HB 315 & 317 requires \(^3\)4 majority vote so we may call for people to come up. It will help getting us out of EMS deficit state wide.

State Fire Chief's Association – Redman, next meeting June 26th in Harrington at Station 50 our Expo with vendors coming down.

State EMS Association – Mike McMichael, our condolences to Ed Angwin for loss of family member. Our next meeting will be with the State Chiefs in Harrington. Also our nominations and elections night. Delaware State Fire School – No Report
State Fire Marshal's Office – Grover Engels, Deputy
Fire Marshal (II) Tate Colburn has completed his
requirements and we are back to full strength in Kent
County. Deputy Fire Marshal Billings from New Castle
has gone back thanks for his assistance these past 5
years. Tanya is in service and Sparks (9 years old) is
retired, both great working dogs. We are grateful for
their service.

Legislature – Senator Ennis, BLS legislation when we had our meetings at the Task Force. It was decided in order to solve the deficit problem everyone would need to have a hand in it; Ambulance Service, County Government & State do their share, Insurance Company's do their share. With everything on the table so that there would be no surprises to them.4 Bills, HB 317 increase State share of gross premium tax by about \$4.7 million to ambulance service. HB 315 adding assessment of \$10 to every motor vehicle violation would generate another \$1.25 million. HB 316 asking county governments to contribute 15% of basic cost of ambulance service, it is true that Sussex contributes \$1.5 million and New Castle is already contributing similar where Kent is not that much money. All 3 counties are affected. HB 317 & 315 have already cleared the house. SB 207 has to have amendments with regards to self-insured companies. We are trying to address the 8.5 million deficit. BLS Paid Employees (a study was conducted) after July 1st any Fire Company with basic life support wants to get in the plan can make an application for coverage on January 1st at the state rate.
