*State Fire Prevention Commission – Ron Marvel, meeting on Tuesday, the Ambulance fund was approved. I have run totals see me after meeting. Reported that there were no companies below the scratch level. All audits are in except for 4 audit extensions. 5 companies in Kent County are delinquent in their DFIRS. We had a very good presentation for the 1917 NFPA Delaware committee. That committee is looking at the differences between the <u>Federal Specification KKK-A-1822: Specification for Ambulances</u>, and <u>NFPA 1917: Standard for Automotive</u>
Ambulances for Ambulance construction. Currently the regulations state we abide by Triple-K standard. There

will be a public hearing concerning adopting NFPA 1917 standard which will go into effect January 2020. **Delaware State Fire School** – No Report

State Fire Marshal's Office – Grover Engel, our K9 Tonya was up in Maine for the week of July 8th and has been certified for another year. We are working with the company's delinquent with their DFIRs report. SB 53 Fireworks bill amending Title 16 to add another festival. I was asked to support bill if 3-year moratorium was added in. I said yes and it was put in. No significant events. The problem we perceive are not the legal ones it is the illegal ones.

*Legislature – Senator Bruce Ennis, Grant & Aid had a 4% increase, discussed Insurance Distribution to include a Kent County increase of 9.2%. Fire Works Bill, allowing certain fireworks. I had an amendment for a 3-year moratorium. When it came from the House it knocked out the 3-year moratorium. SB-39 including Ambulance Assessment that would waive the fee. SB 126 Presumption issue which includes; expands eligibility for Line-of-Duty disability benefits to paid firefighters who work for municipal fire departments and to fire service instructors and fire marshals, passed Senate in flying colors and got hung up in the House.
