The Town Code requires all rental license holders to submit a completed Gross Rental Receipts Tax Form (GRRT) to the Town regardless of whether or not rental income is received. Gross Rental Receipts Tax Forms are to be returned on February 15th and August 15th each year for the time periods noted below. Failure to do so can result in the imposition of penalties as noted in the Town Code.
